**Emergency Consent:** In the event of a medical emergency, I give Evonne Kucera of the Waggin' Tail Inn permission to seek necessary veterinary care for \_\_\_\_\_. I understand that I will be consulted before care is sought, if possible, and that I will be notified at the earliest possibility. I also agree that I will be responsible for the cost of necessary care.

**Inherent risks and assumption of risks:** I acknowledge that there are inherent risks associated with canine boarding such as described below and hereby expressly assume all risks associated with participating in such activities. Inherent risks include, but are not limited to: 1. the propensities of canines to behave in unpredictable ways, including biting and fighting, that may result in injury, harm or death to other dogs being boarded; 2. the Waggin' Tail Inn is located in a desert area that includes certain natural hazards such as snakes, insects, and other wildlife that could cause serious injury or death to a dog.

**Risk of loss and standard of care:** During the time that the dog is in custody of the Waggin' Tail Inn, neither the Waggin' Tail Inn nor Evonne Kucera shall be liable for any sickness, disease, death, or injury which may be suffered by my dog or any other cause of action whatsoever, arising out of or being in any way connected with the care of my dog, except in the event of reckless or intentional conduct. While Waggin' Tail Inn/Evonne Kucera take reasonable steps to protect dogs being boarded from natural hazards and other dogs, they cannot eliminate all risks.

**Hold harmless:** I agree to hold Waggin' Tail Inn/Evonne Kucera harmless from any and all claims arising from damage or injury caused by my dog to any person or another animal, and shall defend Waggin' Tail Inn/Evonne Kucera from any such claims. I agree to disclose any and all hazardous or dangerous propensities of my dog. Waggin' Tail Inn reserves the right to notify me within two (2) days of my dog's arrival if my dog, in Evonne Kucera's sole opinion, is dangerous, unhealthy, handicapped, or otherwise unfit for boarding. Upon such notification, I shall make arrangements to pick up my dog as soon as possible. All expenses incurred for the dog's stay shall be paid prior to the dog's departure.

**Video, Photo, and Image Release:** I hereby grant Waggin' Tail Inn/Evonne Kucera the exclusive rights and permissions to use all media captured on Waggin'Tail Inn premises. Including but not limited to: security footage, photos, and video.
